

## Terms and Conditions for Quarter Two of 2026 Discount Offer

### (Terms and Conditions)

#### 1. Definitions

**AED** means the currency of the United Arab Emirates.

**Applicant(s)** means any individual or Company making an application.

**Application** means an application to DMCCA to avail the Offer and/or a Package by an Applicant.

**Authority** means any local, regional, territorial, free zone, municipal government, ministry, governmental department, commission, board, bureau, agency, instrumentality, executive, utility provider, judicial or administrative body in the UAE, the Emirate of Dubai or DMCCA.

**Basic Business Package** means the original offer launched by DMCCA subject to the terms and conditions available by DMCCA to eligible Applicants pursuant to these Terms and Conditions.

**Business License** means the renewable license issued by DMCCA allowing the Applicant to conduct business within DMCC Free Zone.

**Company** means a registered company maintaining a Business License which is authorised to operate within DMCC Free Zone.

**DMCCA** means Dubai Multi Commodities Centre Authority, governed by Law No. (3) of 2020 (as amended) issued in the Emirate of Dubai and situated at P.O. Box 48800, Uptown Tower, Uptown Dubai, Dubai, United Arab Emirates and being the governing authority of the DMCC Free Zone.

**DMCC AI Centre** means DMCC Free Zone AI ecosystem, located on the 12<sup>th</sup> Floor of Uptown Tower in Uptown Dubai and which focuses on AI businesses.

**DMCC AI Package** means the business setup package for a Business License in the DMCC AI Centre made available by DMCCA to eligible Applicants pursuant to these Terms and Conditions.

**DMCC Business Centre** means a center where sharing desks and offices are leased out by DMCCA to Company.

**DMCC Crypto Centre** means DMCCA cryptocurrency ecosystem, located on the 12<sup>th</sup> Floor of Uptown Tower in Uptown Dubai, focused on crypto business, including but not limited to Companies developing blockchain enabled trading platforms to firms offering, issuing, listing, and trading crypto assets.

**DMCC Crypto Centre Package** means the business setup package for a Business License in the DMCC Crypto Centre made available by DMCCA to eligible Applicants pursuant to these Terms and Conditions.

**DMCC Free Zone** means the free zone of DMCCA, governed by Law No. (3) of 2020 (as amended) issued in the Emirate of Dubai.

**DMCC Gaming Centre** means DMCC Free Zone Gaming ecosystem, located on the 12<sup>th</sup> Floor of Uptown Tower in Uptown Dubai, which focuses on gaming and e-sports businesses.

**DMCC Gaming Package** means this business setup package for a Business License in the DMCC Gaming Centre made available by DMCCA to eligible Applicants pursuant to these Terms and Conditions.

**First Stage** means, in relation to an Application to avail a Package, the creation or submission of the relevant online Application form acknowledging acceptance of these Terms and Conditions in the form prescribed by DMCCA.

**Flexi Desk(s)** means a Standard Flexi Desk or a Special Desk.

**Jumpstart Package** means the original offer launched by DMCCA subject to the terms and conditions available at this [link](#).

**Late License Renewal Penalties** means a fine imposed for renewing after the Business License has expired.

**Late Lease Renewal Penalties** means a fine imposed for renewing a **DMCC Business Centre** lease after the end date has passed.

**Laws** means all legislation, decrees, resolutions, acts, statutes, ordinances, rules or regulations, directives and other orders, treaties, by-laws, codes of practice and other subordinate legislation, of any Authority.

**Offer** means this offer made by DMCCA to any Applicant subject to these Terms and Conditions as further described in Clause 2.

**Offer Launch Date** means the date on which the Offer was launched by DMCCA being 21 May 2026.

**Offer Period** means the period of availability of this Offer starting from the Offer Launch Date and ending on 30 June 2026.

**Package(s)** means all together or any individually the Standard Package, Basic Biz Package, DMCC Crypto Centre Package, DMCC Gaming Package, DMCC AI Centre Package, Jumpstart Package, Technology Package and the Prime Plus Package.

**Prime Plus Package** means the original package launched by DMCCA subject to the terms and conditions available at this [link](#).

**Serious Offence** means wrongdoing such as an inspection related violation(s) or involvement in a court case(s).

**Standard Package** means standard company setup product offered by DMCCA.

**Second Stage** means, in relation to an Application to avail a Package, the payment of the Company setup fees, the execution of the Articles of Association for the Company and the provision of all necessary documentation as required by DMCCA from time to time following completion of the First Stage.

**Special Flexi Desk** means the space which DMCCA will allocate for the Business License within one of the DMCC Business Centers for one year and including one visa only, which the Applicant is allowed to use for one hour per month.

**Standard Flexi Desk** means the desk at one of the DMCC Business Center which has a validity of one year and is limited to three visas and allows the Applicant to use it four hours per week.

**Third Stage** means in relation to an Application, the execution of the agreement for a co-working space in in DMCC AI Centre and any other documentation required by DMCCA from time to time further to the completion of the First Stage and the Second Stage for the issuance of the Business License.

**UAE** means the United Arab Emirates.

**VAT** means value added tax as defined by Federal Law by Decree No. 13 of 2016 concerning the establishment of Federal Tax Authority.

## 2. Offer

2.1 Subject to Clauses 3.10 and 3.11 below, DMCCA shall make the Offer available to any Applicant or Company that makes an Application within the Offer Period, subject to these Terms and Conditions.

### 3. Offer Conditions

3.1 The Offer is only available for:

- (a) An Applicant registering using a Package or existing leads who, at the time of the Offer Launch Date have completed no more than the First Stage of their Application;
- (b) Any new Applicant who has submitted their application prior to the Offer Launch Date but has only received initial approval and/or are in the process of obtaining such approval; and
- (c) Existing Applicant in respect of the renewal services and benefits, as set out in Clause 2.3 above.

3.2 Notwithstanding any other condition set out in this Clause 3, to be eligible to avail the New Company Offer with DMCC premium offices located at Jewellery & Gemplex and the applicable discounts as described at Clause 2.2, the Applicant must:

3.5 DMCCA cannot guarantee the grant of any residency visa which is subject to UAE federal security checks and approvals. DMCCA reserves the right to deny any Application, without incurring any liability to the Applicant or any third party, for failure by an Applicant to obtain a residency visa.

3.6 The Offer shall at all times be non-exchangeable, non-transferable and non-negotiable and cannot be combined with other special offers or discounted schemes except as otherwise set out in these Terms and Conditions.

3.7 The Offer shall not be available for:

- (a) companies wishing to alter their Business License;
- (b) new Applicants who have completed the Second Stage of their Application; and
- (c) Applicants who have completed the Third Stage of their Application.

3.8 Where the Applicant does not meet the requirements to avail the Offer as set out in these Terms and Conditions, the Applicant shall be liable to pay all fees applicable in respect of their Application at standard rates.

- 4.2 Nothing in these Terms and Conditions shall limit or exclude the Applicant's liability in respect of any liability for willful or deliberate default, reckless misconduct, fraud, gross negligence, criminal conduct or corrupt practices or the Applicant's liability in respect of any and all of its indemnity obligations under these Terms and Conditions.
- 4.3 Neither DMCCA and DMCC Free Zone, nor any affiliate, officer, director, employee, attorney, or agent of DMCC Free Zone and DMCCA shall have any liability with respect to the Applicant, and the Applicant hereby waives, releases, and agrees not to sue any of them upon, any claim for any special, indirect, incidental, or consequential damages suffered or incurred by the Applicant in connection with, arising out of, or in any way related to, these Terms and Conditions or the Offer.

**5. Governing Law and Jurisdiction**

These Terms and Conditions and the Offer are governed by the Laws as applicable in the Emirate of Dubai, UAE and any dispute arising out of or in relation to these Terms and Conditions or the Offer will be subject to the exclusive jurisdiction of the Dubai Courts.
